

Maverik Center Ice Rental Terms and Conditions

Per Current Health Guidelines

For all Coaches, Participants and Patrons

As outlined in the state's Utah Leads Together plan, the current health guidelines ask Patrons to take extreme precautions when considering participation in **GROUP/TEAM PRACTICES, GAMES, CLINICS OR CAMPS.**

The Maverik Center may offer group training sessions and games, at the team level for groups of fifty (50) individuals or less, including coaches, adult assistant(s), team representative(s), and players.

Facility Requirements and Restrictions for renting Teams/Organizations/Individuals:

- **Teams/Organizations may arrive to the Maverik Center no earlier than 15 minutes prior to their reservation START TIME.**
 - *Locker room access is provided 15 min. prior, & rooms must be vacated no later than 15 Min. following the reservation end time. Home dress is recommended due to limited locker room time.*
- **Dry-land, warm-ups or other team activities are not permitted indoors.**
- **Each team or group must provide Maverik Center with a current roster or participant.**
- **Spectators are not permitted during practices, trainings, camps, or clinics times.**
- **Spectators are permitted during games at the sole discretion of Maverik Center not to exceed a capacity of 100. Organization renting ice is responsible for enforcing venue capacity and ensure contact tracing in accordance to state and local guidelines.**
- Group/Team activities must be limited to 50 or less participants.
- **All individuals entering the Maverik Center will be required to wear a mask throughout the venue except for on the ice. All Coaches must wear masks while on the benches and all patrons in the stands when permitted, are required to wear masks.**
- Players and coaches should maintain social distancing when not actively practicing or playing.
- Organization or group must symptom check players and coaches prior to any team or group activity.
- Do not let players/coaches participate or be on-site if they are sick, experiencing a fever, cough, new loss of taste or smell, sore throat or difficulty breathing.
- **Report confirmed cases of COVID-19 to Maverik Center immediately.**
- It is your responsibility to ensure that group or team interactions are limited to individuals who have been following recommended distancing/hygiene guidelines.
- It is your responsibility to take precautions in protecting yourself and organization using disinfectants, rubber gloves, not touching your face, wearing face coverings, and social distancing, etc.
- Do not linger longer than necessary in the Locker Rooms and entrance areas.
- Please do not congregate in front of entry ways to the facility or rooms, or within the waiting areas.
- Maintain 6 ft social-distancing, especially entering and exiting the facility.

Failure to comply with any of the above may result in expulsion from facility and may risk future rentals with the Maverik Center.
