Required Medical and Emergency Information The undersigned NNU Soccer Camp (a) participant _____, and/or (b) his/her parent/guardian _____ if the participant is a minor or under the age of 18, and/or (c) coach, assistant coach, trainer, spectator or other party (collectively "Applicant"), each in consideration of the use of the facilities at Northwest Nazarene University, Nampa, Idaho, whether located on the campus of Northwest Nazarene University or not, do by this document, release and forever discharge Northwest Nazarene University, the Northwest Nazarene University Soccer Camp program, and their agents, employees, independent contractors and assigns (collectively "NNU") of and from any and all manner of action or actions, cause or causes of action, suits, injuries, or any other claims or demands rising out of our use of any facilities of NNU, or our participation in the NNU Soccer Camp. I hereby further agree to indemnify and hold harmless NNU of and from any and all manner of action or actions, cause or causes of action, suits, injuries, or any other claims or demands rising out of our use of any facilities of NNU, or our participation in the NNU Soccer Camp whether based on NNU's negligence or otherwise. I further agree: 1. That the Guardian hereby acknowledges that the Applicant has permission to participate in the NNU Soccer Camp on the NNU campus in Nampa, Idaho, or at such other locations as may be held. 2. That the Applicant and Guardian hereby acknowledge that Applicant is in good physical condition, sufficient to take part in the NNU Soccer Camp. If the Applicant suffers from any physical or mental ailment, injuries, allergies or other physical or mental conditions of which NNU should be aware, Applicant and Guardian hereby agree to physically attach a signed exhibit to this Agreement, advising NNU of such ailments. If no such signed document is attached to this Agreement, Applicant and Guardian agree that no such ailments exist as to the Applicant. 3. That the Applicant and/or Coach is covered by the medical insurance identified below, in an appropriate amount and with appropriate coverage for the Applicant's participation in the NNU Soccer Camp. 4. That in case of illness, accident, or injury to the Applicant, the Applicant and Guardian do hereby grant our consent and permission for NNU to obtain any medical care and treatment for the Applicant which NNU may deem necessary, including care and treatment by a physician, athletic trainer or hospital emergency facility. I further agree to assume full responsibility for any medical expenses incurred by the Applicant as a result of such illness or injury. 5. That I hereby acknowledge that the NNU Soccer Camp holds the exclusive right to deny admission or to dismiss any Applicant from the NNU Soccer Camp, as NNU may in its discretion decide is necessary. In the event of such denial or dismissal, no refund shall be paid by NNU to Applicant, Guardian or Coach. 6. That NNU and the NNU Soccer Camp may, without further consent, payment, permission or license, utilize any photographs, pictures, images, videos, and likenesses of us, whether analog or digital, for use by NNU for any lawful purpose. 7.
