

RELEASE AND WAIVER OF LIABILITY AGREEMENT

I/We, _____ ('Parent'), acknowledge that the minor child or children identified below, have voluntarily decided to participate in the Fenwick High School Hockey Club skates coached by Nick "Chip" Chiappetta. The skates will involve recreational activities typical of a Youth Hockey practice/camps (the "Activities"). I am familiar with and knowledgeable about what these Activities are.

I/WE AM/ARE AWARE THAT THE SKATES AND RELATED ACTIVITIES ARE HAZARDOUS AND THAT THE MINOR(S) IDENTIFIED BELOW, COULD BE SERIOUSLY INJURED OR KILLED. AS PARENT(S) OR GUARDIAN(S), I/WE HEREBY GRANT PERMISSION FOR THE MINOR(S) IDENTIFIED BELOW TO PARTICIPATE IN THESE ACTIVITIES, WITH KNOWLEDGE OF THE DANGER INVOLVED, AND I/WE AGREE TO ASSUME ANY AND ALL RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, FOR THE MINOR(S) IDENTIFIED BELOW.

I/WE AM/ARE AWARE THAT WHILE EVERY EFFORT WILL BE MADE TO HOLD THESE SKATES IN ACCORDANCE WITH STATE AND LOCAL COVID-19 REGULATIONS AS WELL AS WITHIN THE USAH AND AHAI GUIDELINES REGARDING COVID-19, A PARTICIPANT MAY BE EXPOSED TO THE COVID-19 DISEASE. I/WE FURTHER ACKNOWLEDGE THAT OTHER THAN FENWICK HIGH SCHOOL HOCKEY CLUB'S COMMITMENT TO FOLLOW STATE AND LOCAL COVID-19 REGULATIONS AS WELL AS THE USAH AND AHAI GUIDELINES REGARDING COVID-19, I/WE AM/ARE NOT RELYING ON ANY REPRESENTATIONS BY FENWICK HIGH SCHOOL HOCKEY CLUB OR ANY OF ITS COACHES OR REPRESENTATIVES REGARDING COVID-19 OR THE EFFECTS OF EXPOSURE THERETO. THE DECISION I/WE HAVE MADE TO ALLOW THE MINOR PARTICIPANT TO PARTICPATE IS BASED SOLELY ON INFORMATION REGARDING COVID-19 FROM SOURCES OTHER THAN FENWICK HIGH SCHOOL HOCKEY CLUB.

As consideration for the minor being allowed to participate in the activities, I/we forever release and discharge Coach Nick "Chip" Chiappetta, the Fenwick High School Hockey Club, their volunteers, coaches, members, officers, agents, team manager(s) and activity organizers (collectively the "Released Parties") from any and all action, claims and demands that I/we, my/our assignees, heirs, next of kin, spouse, legal representative, and/or the minor(s) identified below, may in the future have for any injury, death or property damage, relating to our participation in the outing and/or associated activities; and/or the negligence or other acts or omissions by any of the Released Parties, whether or not directly connected to the outing or the activities, and however caused. I/we also agree that I/we, my/our assignees, heirs, next of kin, spouse, legal representative, and the minor(s) identified below will not make any claim against, sue or attach the property of the Released Parties in connection with any of the matters covered by the foregoing release. I/we agree to pay promptly upon demand any reasonable attorney's fees and costs incurred by or on behalf of the Released Parties should I/we violate this Agreement.

I/WE HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS A RELEASE OF LIABILITY ON BEHALF OF MYSELF/OURELVES AND/OR THE MINOR(S) IDENTIFIED BELOW FOR ALL CLAIMS THAT COULD BE BROUGHT AGAINST THE RELEASED PARTIES RELATING IN ANY WAY TO THE SKATE. I/WE SIGN THIS AGREEMENT OF MY/OUR OWN FREE WILL. I/WE HAVE THE FULL AUTHORITY TO EXECUTE THIS AGREEMENT ON BEHALF OF THE MINOR.
