Nov 4, 2024 Cougar Club Executive Board Meeting 6:00 pm - Field House

Proceedings: 6:02pm meeting called to order by Mike.

General Business: Rhonda made a motion to approve the Oct 7 special session minutes, Chris seconded, and the motion passed 9-0

Funding Requests:

1. Coach Goff, Girls Basketball - overnight tournament, \$3,349 - Rhonda made a motion to approve the funding request, Katy seconded, and the motion passed 10-0

Randy shared that commemorative, pre-purchased printed fan guides will be available for pick up next Friday, during the first playoff game at Cougar Field. A limited number will also be available for sale for \$25.

Rhonda led discussion about Cougar Club organizing postseason fan bus plans. In the past, Cougar Club has coordinated and helped underwrite the cost of charter buses for family & friends for state games, and some longer distance play-offs. Last year bus riders were charged \$35/seat. Potential fan bus plans will develop as the play off season unfolds. If needed, the Cougar Club could fund school buses for student fans.

Board Updates:

Melissa/Concessions - There will be help needed to support concessions for play off games, for both for ours and other games, scheduled at Cougar Field.

Kelly/Spirit Shop - She'll be requesting to have the Monograms & More Spirit Shop trailer for upcoming playoff games and some spring baseball games.

Rhonda/Social Media - She'll be doing media shout outs for sponsors. She also asked the board to repost & share those postings.

Jill Verwold/Treasure - 110K was generated for Cougar Club from the athletic annual fund-raiser. There was a discussion about potentially increasing the current 10% percentage that is donated back to coaches' district athletic funds. Rhonda made a motion to increase the amount to 20% that will be donated back to coaches' activity funds, Chuck seconded, and the motion passed 10-0.

Stoney shared a request to establish an athletic coordinator discretionary fund. Rhonda made a motion to create a \$1500 discretionary fund for the CSHS Athletic Coordinator position, Lauren seconded, and the motion passed 10-0.

Rhonda made a motion to close the executive meeting at 6:58pm, Scott seconded, and the motion passed 10-0
