North Branch Fastpitch Association Waiver of Liability, Release Assumption of Risk & Indemnity Agreement

It is the purpose of this agreement to exempt, waive and release from liability the North Branch Fastpitch Association, for personal injury, property damage, and/or wrongful death, including if caused by negligence of "releasees", or others.

"Releasees" include North Branch Fastpitch Association its affiliate associations, local associations, member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, and each of them, their officers, directors, agents and employees.

"Participant" is defined as the player listed above.

For and in consideration of the undersigned participant's registration with North Branch Fastpitch Association, its affiliates, local associations and member teams and for being allowed to participate in NBFA events and member team activities, participant (and the parent(s) or legal guardian(s) of participant, if applicable) waive, release and relinquish any and all claims for liability and cause(s) of action, including for personal injury, property damage and/or wrongful death occurring to participant, arising out of participation in NBFA events, member team activities, the sport, and/or activities incidental thereto, whenever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant (and participant's parent(s) or legal guardian(s), if applicable) may have are hereby waived, released and relinquished, and participant (and parent(s)/ guardian(s), if applicable) does (do) so on behalf of my/our and participant's heirs, executors, administrators and assigns.

Participant (and participant's parent(s)/guardian(s), if applicable) acknowledges, understands and assumes all risks relating to sports and any member team activities, and understand that sports and member team activities involve risks to participant's person including bodily injury, partial or total disability, paralysis and death, and damages which may arise there from and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including the releasees identified above. These risks and dangers include, but

are not limited to, those arising from participating with bigger, faster and stronger participants, and these risks and dangers will increase if participant participates in sports and member team activities in an age group above that which participant would normally participate in. I/We further acknowledge that there may be risks and dangers not known to us or not reasonably foreseeable at this time. Participant (and participant's parent(s)/guardian(s), if applicable) acknowledges, understands and agrees that all of the risks and dangers described throughout this agreement, including those caused by the negligence of participant(s) and/or others, are included within the waiver, release and relinquishment described in the preceding paragraph. I/We agree to abide by and be bound under the rules of NBFA, including the By-Laws of the corporation and the arbitration clause provisions, as currently published. Copies are available to NBFA members upon written request.

Participant (and participant's parent(s)/guardian(s), if applicable) acknowledges, understands and assumes the risks, if any, arising from the conditions and related premises and acknowledge and understand that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said softball fields, for negligent selection of certain releasees, or negligent supervision and/or instruction by releasees.

Participant (and participant's parent(s)/guardian(s), if applicable) agrees if any claim for participant's personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and hold harmless releasees from any and all claims or causes of action by whomever or wherever made or presented for participant's personal injuries, property damage or wrongful death.

Participant (and participant's parent(s)/guardian(s), if applicable) acknowledges that she/they have been provided and have read the above paragraphs and have not relied upon any express or implied representations of releasees, that they are fully advised of the potential dangers of fastpitch softball and understand these waivers and releases are necessary to allow amateur sports to exist in its present form. Significant exclusions may apply to North Branch Fastpitch Association insurance policies, which could affect any coverage. For example, there is no liability coverage for claims of one player against another player.

THIS DOCUMENT RELEASES NORTH BRANCH FASTPITCH ASSOCIATION AND ITS AFFILIATES, COACHES, OFFICERS AND AGENTS FROM LIABILITY FOR BODILY INJURY, PROPERTY DAMAGE AND/OR WRONGFUL DEATH AS SET FORTH HEREIN. I HAVE READ THIS DOCUMENT AND UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS AND ASSUME ALL RISKS BY SIGNING IT AND I SIGN VOLUNTARILY.
