I. State Chair Call to Order (Molly)

II. Financials (Molly/All)

1. Account balance is currently over \$15,000.
  - Only outstanding expense will be the upcoming State Chair workshop, should it take place.

III. Discussion of who is up for rotation on the next round of Regional meets and if we want to repeat this year with the absence of Regionals in 2020 (Molly, Lynn/All)

1. Sara Halverson proposed reassigning the 2020 Regional judges for the 2021 Regional meet.
  - Kirsten Gackowski seconded the proposal.
  - The proposal was unanimously adopted.

IV. State Meets (Molly/All)

1. The committee discussed all state meets for the remainder of the season and the difference between postponing and canceling the season at this time.
  - Kirsten Gackowski made a motion to close/cancel the remainder of the 2020 competitive season for Compulsory and Xcel gymnasts within the state of Oregon.
    - Casey Chandler seconded the motion.
    - The motion was passed unanimously by the committee.
2. Due to the canceling of the season, the committee also discussed how to honor those host gyms who will not be able to hold the championship meets this season.
  - Heidi Fogarty proposed the committee offer first right of refusal for current championship meet hosts for the 2021 season.
    - The proposal was seconded by Susan Engle.
    - A unanimous adoption of the proposal was made by the committee.
