6. Hockey Operations - Off Ice

- Fat Boys tournament has 3, 60 + teams and 5, 50+ teams. Possibility of a few more teams joining by tournament time, ideally one more team at each level. Proposal would be for beer to sold in the Mezz. Catherine will order beer
- March 26-27th, Bantam tournament is scheduled; 4 teams. RF will combine A+B to form a team. Looking for a few more teams to fill.
- Shamrock shootout is 18 teams, looking to fill 48 more volunteer spots
- 500 hours left to be worked. Jody has sent out two emails to families that owe hours.
- Looking to keep the ice in for an additional week, skills assessment, ice rental, extra practices and then shut down on the 30th.
- Jersey committee is recommending that jerseys are purchased every season. The jersey will be easier to manage. They are also recommending "lottery style pick" for numbers. Skater in good standing is asked to pick their top 3 numbers, if there are skaters wanting the same number within in the same age range, there will be a lottery draw.
- Recommendation for old jerseys is to sell them to fund for operations and pennies. If the managers do not collect the jersey's, then they are to collect a check. Recommendation is to sell them for \$25 per jersey or \$40 for a set.

- Projecting positive cash flow. The goal is \$40,000 for the season which allows us to continue to make progress on our long-term plan.
- Major changes in income include collection of fundraising money (both calendar and pizza) and increased projection of concessions.

- Changes in expenses include paying off balance with Rink Tech. We were paying Rink Tech each quarter but paid balance so 3/30 financials would be clear.
- We are expecting increase in our gas bill and balance for Zamboni loaner
