

PRVA Athlete/Staff Requirements and the Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and athletes scheduled to participate to be in our gym. *Parents wishing to remain on site can use outdoor common areas or the parking lot to wait for their athlete(s). Athletes waiting to attend a session will need to wait outside while maintaining social distance from others.*

Furthermore, all participants in sponsored activities at Pacific Rim Volleyball Academy must agree to and abide by the following:

- Follow coaches/Director's directions at All times
- Must wear protective mask upon entering Pac Rim facility & during training sessions as deemed necessary by staff
- Wash hands with soap/water, during every breaks, for a minimum of 20 seconds
- Do not use team room or front lobby to gather
- There will not be any water stations for refilling, so bring plenty of water
- Water breaks will be taken outside
- No Spectators allowed inside of Pacific Rim Facility (parents please wait outside for athlete pickup)
- Upon entering the Pacific Rim facility, each individual will have their , touch free, temperature, scanned...only those within normal temperature range will be allowed entry into facility
- Social distancing of six (6) feet will be maintained at all times
- Please do not bring any personal equipment beyond necessary gear for participation – only synthetic volleyballs will be used during All sessions
- If at any time you are not feeling well, please stay home

Pacific Rim Volleyball Academy (hereafter referred to as the "PRVA") has put in place numerous preventative measures and enhanced cleaning protocols (including facility sanitization after each session) to reduce the likelihood of spreading COVID-19 in PRVA's gym environment; however, PRVA cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at PRVA could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending PRVA and that such exposure or infection may result in personal injury, illness, permanent disability, or death.

I understand that the risk of becoming exposed to or infected by COVID-19 at PRVA may result from the actions, omissions, or negligence of myself and others, including, but not limited to, PRVA employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at PRVA or participation in PRVA programming ("Claims").

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless PRVA, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of PRVA, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any PRVA activity.
