### FRONTIER SKATE PARTICIPATION AGREEMENT, RELEASE

### OF LIABILITY, WAIVER OF CLAIMS AND ASSUMPTION OF RISK

**BY SIGNING THIS DOCUMENT YOU MAY BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE**

**TO:** The Arena ("Arena") and the League ("League") and their owners, officers, directors, agents, employees, and/or representatives:

**ASSUMPTION OF RISK:** I am aware that ice skating and hockey involve certain inherent risks, dangers and hazards which can result in serious personal injury or death. I am also aware that ice skating arenas contain potential dangers to the ice skating public. **As such, I hereby freely agree to assume and accept any and all known and unknown risks of injury while participation in ice skating and ice hockey activities. I further recognize and acknowledge that the risks inherent in the sport of ice skating can be greatly reduced by: taking lessons, abiding by the Skater Responsibility Code (now know as 'Your Responsibility Code') and using common sense.**

**RELEASE AND WAIVER OF CLAIMS AGREEMENT:** In consideration of allowing me to participate in the ice skating activities at the Arena, I hereby agree as follows:

- 1. TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against the Arena and/or the League resulting from the League's activities at the Arena.
- 2. TO RELEASE** the Arena from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer, as a result of my participation in the activity described in this Agreement, due to any cause whatsoever, including negligence or breach of contract on the part of the Arena and/or the League in the operation, supervision, design, or maintenance of the Arena.

**ENTIRE AGREEMENT:** In entering into this Agreement, I am not relying upon any oral or written representation other than what is set forth in this Agreement.

**I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE ARENA AND THE LEAGUE.**
