



HOTEL RULES AND POLICIES

1. Any team whose home rink is greater than 60 miles from the tournament host rink, will be considered an **out-of-town team**, and will be required to comply with SAHOF's hotel policies and procedures.
2. As a condition of acceptance into the SAHOF State Championships ('SSC'), all players and Team Staff of **out of town teams** MUST reserve rooms through House My Team portal and stay in an authorized hotel, at tournament rates. No other rates, discounts or hotel reward points, regardless of how obtained will be honored. No exceptions. Failure to comply and/or attempts to circumvent procedures and obligations will result in the following:
 - a) Individual Offense, player or Team Staff member will be ineligible to perform in the 'SSC', until a fee of \$150 is paid to SAHOF to reinstate eligibility
 - b) If more than (3) families on the same team are not adhering to the Hotel Rules and Policies, the team will be subject to elimination from 'SSC' eligibility unless fees of \$150 each are paid to reinstate players
 - c) If more than (5) players on the same team are not adhering to the Hotel Rules and Policies, the team will be immediately eliminated from 'SSC' eligibility. Registration fees are non-refundable and future acceptance into the 'SSC' will be subject to review.
3. Each team is required to use the [House My Team](#) portal and is responsible for creating a Group Room Block with the number of rooms required to accommodate their roster. You may contact *House My Teams* directly via email (angi@housemyteam.com) or phone (844-898-6346) to create the Group Room Block in lieu of the *House My Team* portal.
4. A Weblink including the booking instructions will be formatted and emailed directly to the Team Manager unless requested otherwise. It is that person's responsibility to forward the Booking Link to all families of their team. The Booking Link gives direct booking access to the block specifically created for the team.
5. Should further assistance be needed with setting up a team room block, with the addition of more rooms to an existing room block, or if there are questions regarding the link, DO NOT call the hotel directly. Contact *House My Team*.
6. All hotels attempt to keep your team as close together as possible. However, keep in mind that special requests and rooming list changes may tend to fragment your block on various floors of the hotel.
7. The hotel will accept individual cancellations until 6:00 pm 72 hours (3 days) prior to arrival for the listed party. Individuals not canceling more than 72 hours in advance will be considered a "no show" and will be charged for one room night plus tax. Early departures (parties checking out earlier than the departure date) are subject to fees determined by the hotel (typically one night's room and tax).
8. Teams cancelling more than 50% of their entire room block within one (1) week of the 'SSC' start date will be subject to charges for one night per room plus tax, for their entire block of rooms originally listed on the rooming list and subject to elimination if cancelled for unjust cause.
9. Specific hotel check-in times are posted on the Hotel Information Page. All rooms are guaranteed for late arrival.
10. Teams requesting lodging at the same hotel with other teams should indicate this to House My Team, immediately upon registering. House My Team and the 'SSC' will accommodate these requests whenever possible, but it cannot be guaranteed that suitable blocks will be available when the registrations are submitted. The Hotel Weblink is on a "first come, first served" basis and once the tournament website launches, demand can be extremely high for those hotels closest to the facilities.
11. Each hotel has their own policies regarding property damage and/or disruptive behavior. Guests are responsible for being aware of and ensuring they comply with those policies. Property damage and/or continued disruptive behavior may result in removal from the hotel premises. No refund of hotel or tournament registration fees will be made in this case.
12. All individuals must adhere to the current city/state and property guidelines regarding COVID-19. This may include wearing masks in common areas, gathering bans within the lobby areas and completing any health and safety screenings/paperwork requested by the hotel.
13. SAHOF, 'SSC' and House My Team are not responsible for any hotel charges due to late cancelation resulting from a COVID-19 caused withdrawal from the event.
