A meeting for the LVBC was called to order at Cornerstone by President Kevin Daily at 7:31pm.

Minutes:

Minutes were reviewed. **Motion to approve minutes by Colin Rafter, Seconded by Dawn Clessuras. Unanimously approved.**

Financial Update:

- Colin Rafter presented the financial update. Revenue was mainly from Fall dues and concession stand. Expenses paid out were USABL league dues for Fall Travel. Net loss for the month of \$3k. Overall, for the year we are showing a loss of \$12k. This should be offset by Spring Travel deposits. Estimating a positive \$5-6k net income for the year which will go to the capital improvement fund.

Rec Update:

- Fall Rec. Overall, the program is competitive and kids are improving. Season ends in two weeks.

Travel Update:

- Fall Travel. Overall, the program is competitive and running well.

- Travel Coordinator Vote. Jacob Ulm was nominated as Travel coordinator. Kevin Daily asked for any additional nominations. None were noted.
 - **Motion to approve Jacob Ulm as Travel Coordinator by Colin Rafter, Seconded by Rob Baker. Unanimously approved.**
- Travel tryouts. Registration closes Friday October 17th. Discussed scoring and scheduling of tryouts. A rubric was created for scoring to ensure consistency among scorers. Discussed possibility of bringing outside evaluators, however it was discussed that the cost was expensive and we still had complaints from parents. Makeup day for tryouts is scheduled for October 22nd at 7pm.
- Indoor practices. Last year we used Allamuchy for the younger kids and ITZ in Mount Olive for the older kids. Looking for another facility this winter for older kids as ITZ has moved their facility.

Board Updates:

- Concession Stand. Stand is closed for the season.
- Equipment. Equipment will need to be returned to Jim for fall.
- Sponsorship. Signs at Palmer need to be taken down. Rishi advised that most have been taken down and the remainder will be done by next week. Next year we will have smaller sized banners with bungees and wind slits.
- Uniforms. No update. Team store will be opened for Christmas in next few weeks. It was suggested that the store add Sun Shirts, which will be considered if available.
- Field Maintenance. Shed needs to be fixed. Mound on Palmer 4 will need to be repaired or replaced. Rob will reach out to his contact.

- **New Board Members.**
 - Brian McKenna was voted in as a new Board Member. **Motion to approve Brian McKenna as new Board Member by Kevin Daily, Seconded by Jacob Ulm. Unanimously approved.**
