

WAIVER OF LIABILITY

I/WE, _____ on behalf of ourselves and, if applicable, as the parents or guardians of _____ (“Player”) do hereby agree and understand that there are inherent risks in participating in the game of lacrosse, conditioning and related activities including but not limited coming into physical contact with others at the training fields, facility or the equipment associated with the game of lacrosse, conditioning and related activities.

I/WE do hereby give my/our consent and permission for emergency first aid to be rendered to the Player if necessary.

I/We do hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT-TO-SUE Moorestown Lacrosse Club, Inc., and all their Board of Directors, managers, coaches, employees, agents, organizers, sponsors, supervisors, volunteers, and participants (collectively, “Releasees”), for any claim arising out of any injury, including but not limited to death, to me/us, the Player and/or my/our family member(s), whether the result of negligence, gross negligence, any act or omission or for any other cause, except to the extent covered by accident or liability insurance, and I /we further agree to indemnify and hold them harmless against any such suits or actions.

I/We am/are aware there are risks to myself/ourselves and my Player son/daughter/ward of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus known as severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), which is responsible for Coronavirus Disease (“COVID-19”), and/or any mutation or variation thereof, and I/we, for myself/ourselves and on behalf of my Player son/daughter/ward, our family members, our heirs, assigns, personal representatives and next of kin, hereby RELEASE, WAIVE, INDEMNIFY, AND HOLD HARMLESS the Releasees from any and all claims, demands, losses, and liability arising out of or related to any illness, injury, disability or death related to COVID-19 that I /we or my/our Player son/daughter/ward or other family members may suffer, WHETHER ARISING FROM THE NEGLIGENCE, GROSS NEGLIGENCE, ANY ACT OR OMISSION OF MOORESTOWN LACROSSE CLUB, INC. OR THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. On behalf of my

Player son/daughter/ward, myself/ourselves, and our heirs, executors, administrators, assigns, and representatives, I/we hereby recognize that we may be at a higher risk of contracting COVID-19 as a result of participating in the activities, events and opportunities offered by Moorestown Lacrosse Club, Inc., and hereby assume the risk that I/we or my/our Player son/daughter/ward may contract COVID-19.

I/WE acknowledge that I/WE and our Player son/daughter/ward must comply with all policies and procedures established by Moorestown Lacrosse Club, Inc. from time to time, in addition to all policies and guidelines established by the Center for Disease Control, the State of New Jersey and its applicable agencies and local guidelines and recommendations.

By signing below, I/we acknowledge and represent that I/we have read this Waiver of Liability set forth herein, that I/we understand it, and that I/we sign it voluntarily as my/our own free act and deed, including without limitation the Release of Liability and Indemnification requirements contained in this document; that I/we am/are sufficiently informed about the risks involved in myself/ourselves and my/our Player son/daughter/ward participating in the events and activities offered by Moorestown Lacrosse Club, Inc. to decide whether to sign this document; that no oral representations, statements, promises or inducements, apart from the foregoing written agreement, have been made; that I/we am/are at least eighteen (18) years of age and fully competent to execute this document; and that I/we execute this document for full, adequate, and complete consideration, with the intent to be fully bound by the same. I/we agree that this Waiver of Liability shall be governed by and construed in accordance with the laws of the State of New Jersey, and that if any of the provisions set forth herein are found to be unenforceable, the remainder of this Waiver of Liability shall be enforced as fully as possible and the unenforceable provision(s) shall be reformed or modified to a reasonable extent required to permit enforcement of this Waiver of Liability as a whole.
