2021 NCR AREA CHAMPIONSHIP TOURNAMENT GUIDE

PRIORITY INFORMATION

Balls

NCR will provide Molten balls for all matches.

Warm up balls will NOT be provided. All teams must bring their own warm up balls.

Bench Roster

Team rosters must have one (1) adult head coach and a minimum of 6 players up to a maximum of 15 players. In addition, teams may have a maximum of three (3) assistant coaches. All of these individuals may be on the bench during play.

Note - up to 20 individuals (includes 1 head coach, players, assistant coaches and team managers) who are **officially rostered** on the team will be admitted into the event for free.

Check-In

All head coaches must turn in one (1) hard copy of their official USAV roster at the site director's table prior to their first match of the tournament. The USAV roster must be signed by the team representative at check-in. Official USA Volleyball Rosters are printed from the club's Governing Seasons in their SportsEngine HQ.

COVID-19 Expectations

NCR recognizes that COVID-19 mandates differ throughout the country. This tournament/site will follow current practices taking place in the state of South Dakota.

However, in order to maintain the safety of all tournament attendees, NCR does expect that participants and spectators will:

- Wash hands often
- Stay home if they are sick

In addition to the above expectations, NCR also strongly encourages the following:

- Wear a mask that fully covers your nose and mouth – includes participants and spectators
- Maintain at least 6' social distance from others not in your immediate family
 - All teams may remain in the facility when they are not playing but we ask that you do leave the gym – a lounge area will be provided
 - Spectators are encouraged to leave the facility when their team is not playing

Emergency Modifications

Should an occasion arise (facility or personnel issues, Act of God, emergencies, city curfews, etc.) affecting the locations of the facilities or clubs participating in the NCR Area Championships, modifications may need to be made to the tournament schedule, including the possibility of shortening playoff matches as follows:

- Playoff matches will be best of 2 sets
- If teams split sets, the team with the higher point differential will advance
- If there is an exact tie (e.g., 25-21, 21-25), one additional point will be played. The winner of the playoff point will advance.

The Region will do everything possible to ensure the event can take place and as much volleyball as possible can be played, while still adhering to the local safety guidelines; however, should a tournament need to conclude prior to completion, a champion will not be named.

Entry Schedule

An entry schedule will be provided for teams and spectators.

Officiating/Scorekeeping

- **A paid R1 referee will officiate all matches.**
- **Teams will need to provide one (R2), two (2) line judges and two (2) score table attendants when they are the work team**
 - No libero tracker will be utilized in order to reduce the number of individuals at the score table
 - Please make sure work team members are on time and ready to go
 - All work team members are encouraged to wear **masks** covering their nose and mouth at all times
 - All work team participants must pay attention to play – no phones or food
- **A work team schedule can be found online on advancedeventsystems.com in conjunction with the match schedule**
 - To access the work team schedule, go to the tournament on AES, click on your team's age division and then click on your team's **Pool Sheet** – work teams will be listed to the far right on the pool schedule
 - Failure to provide the officiating crew for your assigned matches could result in the forfeit of the first set of your next match or further penalty if it is your final officiating assignment of the day

Roster Requirements – USAV Official Rosters

This is an NCR-USAV sanctioned event which requires valid rosters for the safety of all participants.

- All rostered participants (players, coaches, team reps, etc.) must be current and verified USAV members
- Teams must have a Head Coach (adult) on the bench
- All rostered adults must have a current USAV background screen and be SafeSport certified
- Teams must have a minimum of 6 players rostered and may have a maximum of 15 players
- Teams must be in full matching uniforms per USAV (unless a waiver has been provided in advance)
- Any team that fails to comply with roster requirements may receive sanctions.

Rosters must be submitted into AES from the SportsEngine Governing Season.

FINAL DEADLINE FOR TEAM ROSTER SUBMISSION IS SUNDAY, APRIL 18, 2021 AT 11:59 PM CST.

Spectator Admission

- **Each team will be allowed a maximum of 2 spectators per player**
 - Individual spectators will purchase their own ticket through the Vanco Events online ticketing system in advance of the tournament - **no admission sales will take place on site during the tournament**
 - An online purchase link will be provided to share with players/parents
 - Admission is \$10 per person for the day
 - Tickets are valid **ONLY** for the specific site and age division that the ticket is purchased for
 - Children 4 and under do not need a tournament ticket if sitting on a lap
- Spectators should enter the facility at their designated time - **REFER TO ENTRY SCHEDULE** for spectator entry times
 - **Spectators can either print out their Vanco ticket or show it on their mobile device when entering the event**
 - They will receive an admission wristband upon entry that will provide them with in and out access for the designated site throughout the day
 - Wristbands cannot be shared and are to be worn around the wrist **ONLY** - they should not be placed on purses, bags, etc.
 - The wristbands will be color coded for each day/venue – thus the spectator will only have access to the particular session that his/her team is scheduled in
- **Spectators are encouraged to leave the facility when their team is not playing**

Tournament Format, Match Format & Tie Breaking Procedures

- Teams will typically be placed in either pools of three (3) or four (4) depending on the number of teams in their division
- All teams will play pool play then playoffs
- **Pool Play Round**
 - Pool play matches in 4 team pools consist of 2 sets only - to 25.
 - If there is a tie (e.g., 1 set to 1 set), the match will be recorded as a tie
 - Pool play matches in 3 team pools play 3 sets to 25 regardless
 - If teams are tied at the end of the Initial Pool Play round, the following tie-breaker criteria will be used in this order without repetition to determine a team's placement in the playoff round (there are NO tie-breaking sets played for this event):
 - Head-to-Head (only if 2 teams are tied)
 - Set %
 - Point Ratio
 - Coin Flip
- **Playoff Round**
 - Playoff matches will be best of 3 sets – first 2 sets to 25, third set (if necessary) to 15 – no cap on any set.

GENERAL INFORMATION

Awards

The **first and second place teams in the Gold Playoff Division** in each age division will receive an award.

Concessions

Concessions will be available on site.

Division Modifications

11s and 12s

- The net will be set at 7'0" for the 11s and 12s divisions
- The Molten Volley Lite ball will be used for all matches (provided by NCR)
- The three-serve rule that allows a player to serve only three times **will not be used**
- The service line will be moved in 7 feet

14s Teams Playing in 15s Division

- If a 14s team is playing in a 15s division, the 14s team may NOT re-toss serves

First Aid

It is recommended that teams bring their own first aid kit. **There will be no trainer provided at playing sites.**

Forfeits

- If a team does not have six players or a USAV verified coach at game time, they automatically forfeit the first set.
- Should a team have 6 players or coach before 10 minutes has expired, the late team will be permitted use of the full court for a 4-minute warm-up before play begins.
- If a 6th player or coach has not arrived by 10 minutes after the scheduled match start time, the entire match will be a forfeit.
 - During pool play, a team that has forfeited can “scrimmage” with five players against their opponent for the allotted time. However, the match will still count as a forfeit.
 - If a team forfeits any match other than their first, they will automatically finish fourth in their pool.
 - During bracket play-offs, no “scrimmage” time will be allowed. **Score for a forfeit is 25-0, 25-0.**

Time Outs

Time outs will be 30 seconds.

Uniforms

All team uniforms must comply with USA Volleyball Uniform Requirements.

Waivered Players

North Country Region allows “waivered” players to participate in NCR hosted events which DO NOT have national bid implications (e.g., SmackFest, Area Championships, Region Championship).

- A player may be waived based on their grade vs. their age
- Boys may participate on a girls’ team through 14u

In both instances, the player MUST receive an approved waiver from NCR in advance of being added to the tournament roster.

Warm-Ups

Pool Play

- Both teams can use their half of the court during the first 2-minute time period
- Teams get the full court for 4 minutes if they did not play the previous match
- If both teams played the match immediately prior to their current match, there will be 2 minutes of shared court warm-up time and then the match begins

Example:

Match 1: 2-4-4

Match 2: 2-4 (4 only for team who was off Match 1)

Match 3: 2-4 (4 only for team who was off Match 2)

Playoffs

- Full 2-4-4 warmup for each match

Weather

The tournament will be held through snow, cold, and rain so plan your travel accordingly as matches will begin on time each day. If a team is late, they run the risk of forfeiting sets, or the entire match, as determined by USAV rules.
