Classifiers' Report:

- Saw 14 athletes in Vegas
- Having difficulty staffing Eastern Semifinal. Western Semifinal is staffed
 - Only 4 re-checks at Eastern – is it worth the cost of \$500-700 flights
 - Board is okay with not staffing
- Confirming that AGM is 4-8 – Board confirms – Will be more costly for classifiers to fly in from West Coast

Referees' Report:

- 1 new certified official from the clinic in Las Vegas, with more requiring extra court time before floor testing. We look to get them this court and test as the opportunity presents itself.
- We have all post season tournaments staffed.
- We did have a hard time getting the eastern semi TDs to respond back, which led to some higher than expected travel costs
- For Nationals we will have an Evaluator present to evaluate officials on court performance
- We have a strong U.S. presence for up coming international tournaments, our officials are being recognized and sought after in both on court and administrative roles:

- **Paralympics in Tokyo:** Darren Roberts as Head Official, Mitch Carr as an on court official, Kerin Banfield as a TC, Josh Kearns as an alternate on court official, Bob Lopez as an alternate evaluator.
