Call to Order: 6:02 pm

Mindy made a motion to approve the April and May 2023 meeting minutes and it was seconded by Lisa Tievy and approved by all.

### Reports:

President: Mindy Schwartz-Oliver

4 Athletic Booster Scholarships were awarded. The recipient's were: 1) Madeleine Khouri, 2) Moises Moncada 3) Jonah Karp 4) Lindsey Ehrenfried.

Mindy, Lisa and Leander met with SGA representatives Sophia Iorio-President and Chay Julien-Vice-President to discuss themes for home football games and merchandise options.

Mindy discussed sponsorships for 2023-24 and will be training in-coming President Sean Gallagher on this process.

Cliff confirmed that he would be having a meeting with all the Fall Coaches on August 7/8 and Fall Meet The Coaches Night will be August 24<sup>th</sup> at 6:30 pm.

Back To School Night-Thursday, September 7<sup>th</sup>

Membership rates will remain the same price as 2022-2023. Motioned was made and Mindy Schwartz-Oliver approved the motion. Lisa Tievy seconded the motion.

Old Business:

fence cup purchasing was approved at April Boosters Meeting but Lisa did not order them yet. Originally, white cups would be ordered but we requested that Lisa look into more school colors or designs. The Board unanimously approved for the cups to be ordered so we could use them for the 2023-2024 school year.

Treasurer's Report: Kellie Hottel

Kellie will distribute the updated reports within the next week.

Per her report, \$17,068.30 was the merchandise total for the 2022-2023 school year and \$25, 518.77 was the concessions total for the 2022-2023-school year.

All taxes have been filed. They will be due in November 2023. Kellie will meet with Stephen Douglas-Incoming Treasurer to review all financial reports and train for the 2023-2024 school year.

Membership: Brittany Marshall-was not present at meeting. She has resigned her position. Dawn Cranford was elected for Membership Chair for 2023-2024 school year.

Concessions/Volunteer Coordinator: Kim Kamensky

Kim stated that she will close out the current year with Kellie Hottel-Treasurer. Expenses that Kim requested for 2023-2024 to begin were Food License for Concession Stand \$100 and money that was previously allocated, from Restaurant Depot/Webstaurant for a Hot Beverage Warmer. Kim will continue as the concession coordinator for the 2023-2024 school year and Michelle Tregoning was elected as the Volunteer Coordinator for Concessions.

Merchandise: Lisa Tievy

Lisa gave an updated report on merchandise sales and requested \$10,000 to fund the merchandise stand for the Fall of 2023. This was unanimously approved by the current board. Lisa is also continuing to sell merchandise through our on-line store. On-line merchandise can be purchased at any time but the store will have to close on the 1<sup>st</sup> and 14<sup>th</sup> of every month in order to fulfill orders in a timely manner.

Lisa plans to sell merchandise at Freshman Orientation, Freshman Parent Meeting, Back-To-School Night and all home football games for the Fall 2023.

Communications: Tara Mungra

Tara continues to support all athletic booster platforms. She will post all Board approved expenses on the main Athletics Boosters page.

Fundraising: Leander Uvary

The Board unanimously approved for Leander to organize the Athletic Booster Fall Photo Fundraiser. Mike Clark and Adam Dube will be the photographers for this event. Leander will obtain contract from Mike for the Board's approval ASAP. Tentative date is: Sunday, October 8, 2023 from 12-5 pm at Fall Creek Farm (part of Ruppert Landscaping). Leander to confirm use of location with Chris Ruppert and will request Tara Mungra's assistance with creating a flyer/advertising for the event, in time for freshman parent/orientation meetings.

Administration: Cliff Elgin

Cliff, Mindy and Board discussed any coach's request for spending and any general athletic booster spending. Some items identified were:

6 new ceiling fans for the Stadium Concession stand. Estimated cost was \$1,200. Mindy approved the motion and Kim Kamensky seconded the motion.

Cliff stated that he was awaiting a quote for additional stadium speakers. Other improvement projects were a grant secured by Greg Kellner for Bermuda grass installation on the current baseball and softball fields. As part of this grant, LED lights would be added to the baseball field scoreboard. The softball field would have the seating area changed to bleachers and it would be ADA Accessible.

Other items identified for purchase were 18 padded chairs for indoor use, new wrestling practice mat, windscreens for the tennis courts, replace screens at stadium entrances. All of this equipment was estimated to be \$14,500 total. Mindy Schwartz-Oliver approved the motion, Lisa Tievy seconded the motion.

Cliff stated that fall schedule is currently being finalized. Once finalized, he will post on the athletic website. We will have five home football games in the fall. Two will be Thursday Home games and 3 will be Friday night games. We will have a football scrimmage on Friday, August 25<sup>th</sup>.
