1. Discussion on the 8/9/10 regional bids.
 - a. The bid from Arizona Dynamics, to host 8/9/10 Regionals in conjunction with level 6/7 regionals the weekend of April 17th- 20th (Saturday- Tuesday) 2021 was awarded.

2. There was discussion and agreement that at all regional competitions in 2021, all coaches, judges, meet workers and spectators would be required to wear a mask at all times. Gymnasts would need to wear a mask at all times, except when actually on equipment, but must have masks on anytime they are gathered around anyone, lined up, and during awards.

3. Regional meet refund Policy. Discussion to have a regional policy for refunding competitions: In the event that the current pandemic causes a cancellation of a Regional Championship Meet, the Region One Administrative Committee recommends a full refund to registered athletes/clubs, (minus unrecovered costs).

Note 1: This refund would be exclusive of any collected head count tax monies collected.

Note 2: The Regional Committees will reimburse any awards costs incurred, provided dates are not used on the awards, as they can be used the following year.

Note 3: Expenses not recouped by the host club, to be subtracted from reimbursements, **must be submitted to the RACC, in writing, and include cancelled checks, or receipts, along with written verification of earnest attempts to recoup those monies.**

4. Due to Covid and likely reduced numbers at regional meets, to help reduce costs, for the 2021 Level 8 Regional meet, judging panels for level 8 will be reduced to 2 panels for this year only.

5. Qualification to Regionals for 2021:

If your state is **not** hosting an in-person state championship, athletes can qualify to Levels 6-10 & Silver - Platinum Xcel Regional Championships as follows:

1. Score from sanctioned competition in 2020 if at the same level
2. In-person sanctioned intrasquad or competition in 2021
3. Virtual sanctioned intrasquad or competition in 2021

If numbers 1, 2 & 3 cannot be met:

4. Video submission of routines on all four events for athletes competing at a new competitive level. Videos need to be submitted to RACC (evelynparadis1@gmail.com) and will be reviewed by RAC. Videos due no later than March 12, 2021 for Levels 6-10 and April 2, 2021 for Xcel Silver through Diamond.

1. Xcel Silver 34.00, Xcel Gold 33.00, Xcel Platinum/Diamond 32.00
2. Levels 6 - 10 34.00
3. Levels 9 & 10 Event Specialists - 9.00
