TOURNAMENT AWARDS

District Tournament sponsors shall furnish: 1st, 2nd and 3rd place team awards if 8 or more teams in tournament, 1st and 2nd place team awards if tournament has 4-7 teams and 1st place team award if less than 4 teams. The USA Softball of Nebraska will designate the type of awards and vendor for all championship tournaments. Awards for individual performance, other than those based on team finish, are prohibited in Junior. Tournament sponsors may furnish additional awards that have been approved by the State Commissioner. Please attach a separate page to the bid form listing any additional awards that will be furnished by the tournament sponsor.
