“2022 USL Spokane Summer Giveaway” Sweepstakes

NO PURCHASE NECESSARY TO ENTER OR WIN.

HOW TO ENTER

You can enter the Sweepstakes by visiting <https://www.uslspokane.com/pages/summer-giveaway>, or by scanning the unique QR code presented at one of the local events throughout the summer including but not limited to Skyfest 2022 taking place on May 14th and May 15th, and Spokane Hoopfest taking place June 25th and June 26th. Once on the page, fans must fill out all required form fields, and will have the opportunity to take actions to gain entries. Fans can enter six (6) different ways for up to 14 total entries. Point values and actions are indicated on the landing page.

Maximum limit of one entry per Entrant per email, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry per day by using multiple/different email addresses, identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes. WINNER SELECTION

Three (3) winners will be chosen by random drawing of all eligible entries during the Sweepstakes Period. For each action taken, the indicated number of entries will be added to the pool. Fans can enter six (6) different ways for up to 14 total entries. Winners will be notified by Sponsor via email on or about July 8th.
