Notice

- Due to the Safer At Home Act in response to COVID-19 pandemic, this meeting was held via computer teleconference.

Minutes

- Agendas and meeting minutes from 1/17/21 were distributed and reviewed. A motion was made by Mr. Younggren, second by Mr. Schmidt, to approve minutes as presented. Motion carried, 8-0.

Financials

- Mr. Taplick was able to provide the group with an updated financial statement to date.
- Mr. Taplick has incorporated all expenditures to date, and included the costs associated with Food Drive donation as well as OHS Scholarships.
- Mr. Taplick still believes we will come in under budget unless unforeseen circumstances arise.

2020-21 Calendar

- The group discussed the need for officially cancelling the season, but at this point an official announcement does not seem to be necessary.
- Amy discussed the upcoming OYB Food Drive coming up next week Feb. 27th at Oregon Area Food Pantry. Amy said that there is still a need for a few volunteers at the site.

Sponsorship

- Mr. Schrimpf asked to chair the Sponsorship Committee again moving forward.
- The group discussed drafting a letter to current sponsors stating our intention to postpone sponsorship requests for the 2020-21 season, with anticipation to resume sponsorship in 2021-22. Mr. Schrimpf will work on drafting a letter and will present to the group for review.

Old Items

- Scholarship Committee should be seeing the applications for the 2020-21 OHS Scholarships in the near future.
- Mr. Younggren is still working on scheduling some training videos and is coordinating with Mr. Siebert and Mr. Wamsley. The videos may need to be filmed at a later time and wouldn't be released until the off-season at the earliest. The hope is to have this on line prior to next season.
- Oregon Youth Sports, Inc. is working on putting together more documentation, and will continue to reach out at a later time.

New Items

- Mr. Crowley will send out information on individual roles and opportunities to participate in committees.
- The group discussed the idea of putting together a 3v3 tournament. More information will follow at future meetings. The potential tournament would probably be scheduled for Summer.
- The group discussed creating a sub-committee to review and improve coaching resources. Mr. Crowley will add this to the committee/role document and will send it to the group.
- Mr. Younggren is continuing to discuss with Mike Carr about getting gym space in the off-season for potential clinics, camps, etc.

School District

- School staff is tentatively scheduled for early March.
- Mr. Heitz will work on getting some budget costs for storage improvements at the high school. He will report back to the group.
