

SABERCAT HOCKEY PROGRAM REGISTRATION & PARENT CODE OF CONDUCT AGREEMENT

Registration:

All registration fees must be completed online. A non-refundable deposit as stated on the website is required to register for SHP. A player is not considered registered until the deposit has been made. Your deposit fee will serve as your 1st payment once a player is selected for a team. Full balances will be due after tryouts. SHP will also offer an optional payment plan for your convenience.

Player Placement & Responsibilities:

The Hockey Director along with the team coaching staff has sole responsibility of player placement on a team. No refunds will be given for players who choose to leave because he/she did not make the team they wanted. Once a player is selected and rostered on a team, they are responsible for paying the season fee registration online within one week. All players are expected to participate in all tournaments selected by the Coach. Players not participating in a tournament are not entitled to any credit. This policy also applies to travel expenses for individual teams and coaches' expense.

Refund Policy:

SHP will issue a refund to a player ONLY if the player is released after tryouts or if a player moves out of state prior to the start of tryouts. The SHP Board of Directors must review all other requests for refunds on a case-by- case basis. Any refunds will be issued only after the roster freeze date, currently December 31st. All approved refunds will be subject to a \$300 administration fee, excluding player releases after tryouts or pre-tryout out of state movement. If a player is on a payment plan and chooses to leave to another association, that player is responsible for the remaining unpaid travel and team fees prior to receiving a financial release from Sabercat Hockey Program.

Parent Responsibilities:

As a parent or guardian of an SHP player I agree that I will handle a concern in the following manner. I agree that I will address my concerns first with the Head Coach/Assistant Coach at the proper place and time. I agree to a 24 hour "no contact" period before meeting with the Coach('s). If resolution is not reached satisfactorily, I will arrange to discuss my concerns with the Hockey Director. If still unresolved after meeting with the Hockey Director, I will address my concerns in writing to the SHP Board of Directors. I will actively support a sports environment for my player that is free from drugs, tobacco and alcohol and understand that violation of this may result in a player's suspension from SHP.

SHP Registration Agreement 2022-2023:

I agree that as a member of the Sabercat Hockey Program to comply with the rules and regulations of USA Hockey and/or CAHA policies and that violations may result in fines and/or suspensions for both parent and player.

Privacy:

Sabercat Hockey Program reserves the right to disclose player information to other youth hockey associations with respect to the player's financial standing.
