



## CHANGES TO 2021 CAHA TOURNAMENT DUE TO COVID-19 EFFECTIVE 1-4-21

This change to the 2021 CAHA State Tournament is effective immediately and is being put in place due to COVID-19 spread. This includes a change in the tournament format and backup plans in case COVID-19 restrictions cause the 2021 CAHA Tournament to be cancelled. USA Hockey has moved the USAH Nationals to April 28 to May 3. Given this change, there is a change to the timing of our Alternative Plans.

The following changes are being made to the 2021 CAHA Tournament:

- 1) **Tournament Location** – South Carolina Tournaments (currently 14U and 16U) will be held as planned in a Best of 3 format in Charleston, SC. North Carolina Tournament will be moved to the Winston-Salem Annex in Winston-Salem, NC. This venue will give us the opportunity to extend out the tournament over an additional day and provide a venue with more space to spread out spectators in this 3100-seat facility.
- 2) **Tournament Timing** – South Carolina Tournaments will remain on the same timing and the North Carolina Tournament in Winston-Salem will be expanded from Friday 2/26/21 to Monday 3/1/21. The schedule will be available by 12/28/21.
- 3) **Tournament Format** – the North Carolina Tournament will now be a 2-game minimum where teams will play 2 preliminary round games with the top 2 teams moving into the Championship Game.
- 4) **Tournament Seeding** – teams will be seeded using MyHockeyRankings that are released on 2/17/21. Teams will be responsible for verifying their MyHockeyRanking games, scores, and opponent information by 2/17/21. Games not included in MyHockeyRankings will not be included in the calculation to select teams.

**ALTERNATIVE PLANS** – CAHA has adopted alternative plans if the 2021 CAHA Tournament cannot be played due to COVID-19 restrictions or precautions.

**PLAN B (only applies to NC teams)** - CAHA will adopt “Plan B” which will be a small series of games played between top 2 teams registered for the CAHA tournament in 14U and the top 3 teams registered for the CAHA tournament in 16U and 18U as determined by the MyHockeyRankings on February February 17, 2021. The determination to move to Plan B will be made by February 19, 2021 – 1 week before the scheduled tournament. These 14U teams will play a Best of 3 format and the 16U/18U teams will play a round robin with the top 2 teams competing in the championship game. Plan B games will take place by April 4. The adoption of this plan will be made if the state or local orders require that events like a tournament cannot be held but individual games can be played. South Carolina teams are already in a Best of 3 format so Plan B only applies to North Carolina teams.

**PLAN C (applies to NC & SC teams)** - CAHA will adopt “Plan C” if the Tournament or Plan B games cannot be played before April 4, 2021 due to state or local COVID-19 restrictions.. Plan C will consist of selecting the top seed in the tournament to move on to the USA Hockey National Championships. The top seed is determined by MyHockeyRankings on March 31, 2021. This determination to move to Plan C will be made by April 4, 2021.

### Updated Timeline

12/21/21 - Registrations due for all teams and age groups

12/28/21 – Signed Addendum agreeing to change due via SportsEngine. Teams may also choose to drop out of the tournament in writing to the Tournament Committee. They will incur no penalty.

1/1/21 – Fees Determined and Communicated to Teams

1/30/21 – Payments Due

2/5-6 – CAHA Tournament in SC for 16U in Charleston

2/19/21 – Plan B will be adopted if necessary. Decision will be made by state.

2/26-28 & 3/1/21 – CAHA Tournaments in NC and 14U in SC

4/3/21 – Plan C will be adopted if the tournament and Plan B cannot proceed.

4/28-5/3/21 – USA Hockey Nationals
