Each entrant must then enter each of the following data points to be eligible for prize.

- Date of Birth
- Zip Code
- Favorite USL Club

Maximum limit of one entry per Entrant per email address, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry by using multiple/different email addresses, identities, registrations or logins, or any other methods may void the entries and Entrant may be

disqualified from the Sweepstakes. 3. Number of points scored in Conference Final Round

Odds of winning will depend on the total number of eligible entries received for the applicable drawing. Winners will be notified by Sponsor via email on or about July 15, 2025.
