16U (CADET) DIVISION DIRECTOR

The responsibilities of the Cadet Division Director shall be as follows:

To Coordinate and Provide Leadership for the Pennsylvania Cadet Wrestling Program.

To Assist with Regional and National Programs and Act as a Liaison to USAW on Behalf of the Cadet Division.

Develop and recruit eligible athletes for the Cadet National Tournament

Work with the Fundraising/Sponsorship director at large for the Cadet Nationals Team

Such Other Duties as Directed by the Board of Directors.

COACHES DIRECTOR

The responsibilities of the State Coaches Director shall be as follows:

To Plan, Schedule, and Conduct Copper and Bronze Level Certification Courses throughout the State.

To Recruit and review eligible applicants and select coaches for the National Teams. If needed, Certify Coaches for the National Teams ensure coaches have completed safe sport requirement.

To be a Ready and Accessible Resource for the Grass Roots Coaches in Advising Program and Coaches' Development.

To be the Lead Agent, with the State Chairman's Oversight and Endorsement, for Coordinating and Scheduling Practices at the National Team Training Camp.

As Directed, to Represent the State Chairman at Designated Meetings and Committees Held at the National Championships.

To Foster and Maintain a Positive Flow of Current Information with the USWOA in Order to Keep Coaching Protocols Current and Effective.

Such Other Duties as Directed by the Board of Directors.

COMMUNICATION AND MEDIA DIRECTOR

The responsibility of the Communication and Media Director shall be as follows:

Develop ways to communicate activities to membership via multi-media.

Release news story of PAUSAW events

Coordinate picture for PA National Teams

Take pictures and PAUSAW major events

Develop a communication plan.

Such Other Duties as Directed by the Board of Directors.

CLUB LIAISON DIRECTOR

The responsibility of the Club Liaison Director shall be as follows:

Interface with each club

Communicate new programs with each club

Handle Club issues

FOLKSTYLE DIRECTOR

The responsibilities of the Folkstyle Director shall be as follows:

To Assist with Regional and National Programs and Act as a Liaison to USAW on Behalf of folkstyle.
Develop and recruit eligible athletes for folkstyle
Such Other Duties as Directed by the Board of Directors.

FREESTYLE DEVELOPMENT HEAD COACH

To provide senior level coaching and leadership to Pennsylvania's National Teams in Freestyle wrestling, and to support the policies of the PAUSAW

FUNDRAISING DIRECTOR

The responsibility of the Fundraising Director shall be as follows:
Design a communication plan and present to board of goals to raise money
Target select business that could possibly contribute to PAUSAW
Build Marketing plan to feature PAUSAW Benefits.
Such Other Duties as Directed by the Board of Directors.

GRECO-ROMAN DEVELOPMENT HEAD COACH

To provide senior level coaching and leadership to Pennsylvania's National Teams in Greco-Roman wrestling, and to support the policies of the PAUSAW

JUNIOR DIVISION DIRECTOR

The responsibilities of the Junior Division Director shall be as follows:
To Coordinate and Provide Leadership for the Pennsylvania Junior Wrestling Program.
To Assist with Regional and National Programs and Act as a Liaison to USAW on Behalf of the Junior Division.
Develop and recruit eligible athletes for the Junior National Tournament
Work with the Fundraising/Sponsorship director at large for the Junior Nationals Team
Such Other Duties as Directed by the Board of Directors.

KIDS DIVISION DIRECTOR – YOUTH DEVELOPMENT DIRECTOR

The responsibilities of the Kids Division Director shall be as follows:
To Coordinate and Provide Leadership for the Pennsylvania Kids Wrestling Programs.
To Assist with Regional and National Programs and Act as a Liaison to USAW on Behalf of the Kids Division.
Develop and recruit eligible athletes for the Kids National Tournament
Work with the Fundraising/Sponsorship director at large for the Kids Nationals Team
Such Other Duties as Directed by the Board of Directors.

MEMBERSHIP DIRECTOR (Prior At Large Position)

The responsibilities of the membership director are to grow our membership by the agreed to percentage specified by the board.
Track the membership numbers and types and report back to board.
Contact new organizations and address the benefits of being a USAW member.
Such Other Duties as Directed by the Board of Directors.

OFFICIALS DIRECTOR

The responsibilities of the Officials Director shall be as follows:

To Provide Leadership and Direction for All Referees within the Commonwealth of Pennsylvania.

To Maintain a Current Listing of All Pennsylvania Referees, and Coordinate Assignment to all PAUSAW Tournaments.

To Ensure the Competency of all Referees through Clinics, Tests, and Observation of Performance. To Serve as Senior Mat Official at All State Championship Tournaments. Recruit and develop youth and new officials.

Promote national and regional attendance among all Mat officials

Such Other Duties as Directed by the Board of Directors.

OPEN DIVISION DIRECTOR

The responsibilities of the Open Division Director shall be as follows:

To Coordinate and Provide Leadership for the Pennsylvania Open Division Wrestling Program.

To Assist with Regional and National Open Programs, and Act as Liaison to USAW on Behalf of the Open Division.

Such Other Duties as Directed by the Board of Directors.

TOURNAMENT MANAGER

The responsibility of the Tournament Manager shall be as follows:

To Provide Leadership and Direction to all Pairing Officials within the Commonwealth of Pennsylvania.

To Maintain a Current Listing of All State Pairing Officials and Coordinate Assignments to All Major State-Wide Tournaments.

To Ensure the Competency of Pairing Officials through Clinics, Testing and Observation of Performance.

To Serve as Senior Pairings Official at All State Championship Tournaments.

Recruit and develop youth and new pairing officials.

Promote national and regional attendance among all pairing officials

Such Other Duties as Directed by the Board of Directors

WOMEN'S DEVELOPMENT HEAD COACH

To provide senior level coaching and leadership to Pennsylvania's Women's National Teams and to support the policies of the PAUSAW.

WOMEN'S DIVISION DIRECTOR

The responsibilities of the Women's Division Director and Co-Director shall be as follows:

To Coordinate and Provide Leadership for the Women's Division.

To Attend and Handle All Competition at All Women's Tournaments.

To Secure a List of applicable State, Regional and National Competitions for Women and/or Any Other Information Pertinent to the Women's Division and Make this Material Available to Anyone Interested.

To Assist with Regional and National Programs and Act as a Liaison to the USAW on Behalf of the Women's Division.

Develop and foster the Women's program in the commonwealth to include working and fostering relationships with other state wrestling agencies, in an effort to promote and continue the growth of the sport in Pennsylvania.

Ensure that Women's specific wrestling items from the PAUSAW community are being brought to and discussed with the PAUSAW Board of Directors.

Such Other Duties as Directed by the Board of Directors.
