**Equipment Use Agreement and Liability Release and Indemnification**

THIS AGREEMENT is made by and between \_\_\_\_\_ a youth skier athlete, hereinafter “the skier athlete”, and the NORTHWOODS NORDIC SKI CLUB, INC., a Wisconsin non-stock, non-profit corporation, hereinafter referred to as “Northwoods Nordic”. Since the skier athlete may be a minor, the parent or guardian of the skier athlete also signs this agreement indicating their approval and endorsement of the agreement.

Northwoods Nordic loans and makes available to the skier athlete for his or her personal use the Nordic ski equipment described in the Ski Equipment Rental Agreement dated : \_\_\_\_\_

Prior to accepting possession of the described Nordic ski equipment, the skier athlete and his/her parent or guardian have inspected the equipment and determined it to be in a safe and satisfactory condition appropriate for the skier athlete’s use. The skier athlete agrees to use the described Nordic ski equipment in a safe and sensible manner only for its intended purpose and only as instructed by coaches and supervising adults.

The skier athlete shall have the possession and use of the described equipment for the duration of the current winter season (or in the case of roller skiing equipment the current dryland roller skiing season) provided that the skier athlete attends all formal Nordic team training sessions (unless excused by a coach or supervising adult). The skier athlete acknowledges that he/she is expected to be participating in Nordic skiing athletics only during the current winter season.

In the event that the skier athlete makes or permits improper or abusive use of the described Nordic ski equipment, Northwoods Nordic reserves the right to demand the immediate return of the loaned equipment and agrees to reimburse the cost of replacement of that equipment to Northwoods Nordic.

Northwoods Nordic Ski Club, Inc., a Wisconsin non-stock, non-profit corporation, hereinafter “Northwoods Nordic”, is pleased to offer you, your child, or ward, Nordic winter sports equipment for your/his/her personal, recreational use. When used in a reasonable and prudent manner, Nordic Sports Equipment, including skis, roller skis, poles, boots, bindings, and related accessories ( “Nordic Sports Equipment”), is not likely to cause serious physical injury or death. But an accident can happen. We cannot guarantee your safety while skiing or roller skiing. When using the equipment you must take personal responsibility for following instructions, observe posted warnings, and use your own common sense and good judgment.

I understand and acknowledge that my experience, physical condition, and medical condition, if any, all contribute to my ability to use the Nordic Sports Equipment safely. Some risks are wholly beyond my control. These include hazards that result from exercise in cold temperatures and in a winter snow environment or when roller skiing on public streets or roads. It is always my responsibility to assess these hazards and refrain from Nordic sports activities that may cause me harm. I understand that the use of this Nordic Sports Equipment involves risks of injury, including injuries as severe as broken bones, paralysis, and death, no matter how much care I may use.

Signing the Ski Equipment Rental Agreement I agree, for myself, my child/ward, and for my/his/her heirs, successors, and assigns, to forever release and discharge NORTHWOODS NORDIC SKI CLUB, INC., its officers, directors, members, agents, volunteers, or their successors and assigns, from any and all actions, costs, suits, demands, claims, damages, losses and liabilities (including reasonable attorneys’ fees) of any type or kind whatsoever arising out of, for any reason or from any cause, injury or death, occurring from, connected with, originating from, or caused by my use of its Nordic Sports Equipment.

I also hereby agree to indemnify, defend and hold blameless NORTHWOODS NORDIC SKI CLUB, INC., and its officers, directors, members, agents, volunteers, or their successors and assigns, from any and all actions, costs, suits, demands, claims, damages, losses and liabilities (including reasonable attorneys’ fees) of any type or kind whatsoever arising out of, for any reason or from any cause, injury or death, occurring from, connected with, originating from, or caused by my use of its Nordic Sports Equipment.

I HAVE READ, UNDERSTOOD, AND HEREBY ACCEPT THE TERMS, CONDITIONS AGREEMENTS STATED HEREIN AND ACKNOWLEDGE THAT THIS AGREEMENT SHALL BE EFFECTIVE AND BINDING UPON ME, MY HEIRS, SUCCESSORS, AND ASSIGNS, AND UPON THE MINOR CHILD/WARD UPON WHO’S BEHALF I SIGN THIS AGREEMENT AND THE EQUIPMENT RENTAL AGREEMENT.
